2026 Pension Indexation Award Announced

The Pension Indexation Award is a Public Sector Pension Plan (PSPP) design feature that provides inflation protection by annually adjusting your pension benefit amount when the funded status of the Plan is greater than 110%.

The PSPP's target Pension Indexation Award is equal to 100% of the change, year-over-year, in the Canada All-Items Consumer Price Index (CPI), which is 2.30% for 2026.

The April 2025 valuation reports the Plan's funded status was above the 110% threshold; therefore, the full 2.30% will be awarded.

The Pension Indexation Award will be applied January 1, 2026.

Please note, if you retired in 2025, your 2026 award will be pro-rated.

Pension Portal – *Pensioner Access Update*

Keeping your pension information up to date

The Pension Information Change form allows retirees to easily report changes in their name, address, direct deposit information and additional tax deductions to Pensions & Benefits. It can be found on www.peipspp.ca under the 'Forms' section.

If updating your direct deposit information, please note:

- the account must be in the name of the member,
- the account must be with a Canadian financial institution, and
- you should keep your old account open until your first pension payment has been deposited into your new account. This will prevent a disruption in your pension payments.

To avoid any disruption to your pension payments, you must also inform the Pensions & Benefits Office of any change to your mailing address. Pension payments will be suspended if, after reasonable effort, this office is unable to connect with you.
